DECLARATION OF PARENTAL DISAPPROBATION CONCERNING INVASIVE COVID MEASURES REGARDING OUR CHILDREN

Dear school principal / school teacher / nurse	
As parents and legal guardians of our child/children:	
	(SSN/HETU

we reprehend the following during our childrens' school day:

Administering any of the variants of the so called COVID-19 vaccination; the administering of any other injections; or administering of any other related cures or medicines for related diseases or symptoms.

Relatedly, we prohibit also the testing of our child/children for the related virus, or any other related or unrelated to the mentioned disease during the school day; by the school, or at the school.

A dubious policy and practice has developed in Finland recently, in which a person under the age of 15 has in many cases been given the opportunity to speak and decide independently in matters concerning himself or herself. The Finnish governmental news agency YLE has delivered the following statements on Dec. 1st., 2021:

The decision to take the vaccine is primarily made by the child themselves if the healthcare professional believes that the child is able to decide on their treatment based on their age and level of development. There is no statutory age limit for a child's independent decision-making, so the child's situation is examined on a case-by-case basis.

THL's policy for minors is that the consent of all guardians is required for the administration of a covid vaccine if the child or young person is unwilling or unable to decide for themselves.

- As these are now smaller children, many of them require parental consent, unlike in the 12–15 age group, says Mia Kontio, THL's leading expert.

Ombudsman for Children Elina Pekkarinen has emphasized that children and young people should be provided with reliable and comprehensible information about the covid vaccine to support decision-making.

The abovementioned statements of experts and officials on informed consent of minors in the age range of 5-11 years concerning so called covid-19 vaccinations are absolutely unacceptable and reprehendable, both legally and morally. A decision on a medical injection – as well as any other medical procedure - of a such a small child must be made with the prior consent of the child's parents. The parents are primarily responsible for the well-being of their own children. A little child can not have an adequately informed opinion on such an irretrievable matter; administering of an injection with the so called consent of that small a child, without the parents possibly even knowing of the matter, is utmostly abusive. Doing it for the supposed or alleged cause of safety or health of other people or the society, is outright criminal.

Pressing on such a role as a subject, ie obliging to "vaccinate", is contrary to the Nuremberg code - a set of research ethics principles for human experimentation stemming from the doctors' trial by US military courts in 1946 and 1947. Pressing on such a role as a subject, ie obliging to "vaccinate", is also contrary to the Declaration of Helsinki of The World Medical Association: a statement of ethical principles for medical research involving human subjects, including research on identifiable human material and data, declared in 1964, amended ninth time in Fortaleza, 2013. In addition, putting pressure on any medical measures is against The 1999 Convention for the Protection of Human Rights and Dignity of the Human Being with regard to the Application of Biology and Medicine: an international instrument aiming to prohibit the misuse of innovations in biomedicine and to protect human dignity, also known as the Oviedo Convention. It is also against the UNESCO Declaration on Bioethics of 2005, setting the global minimum standards in biomedical research and clinical practice. and the decision of the Council of Europe: On 27 January 2021, the Council of Europe adopted a resolution on COVID-19 vaccines: The Parliamentary Assembly urges the Member States and the European Union to: 'ensure that citizens are informed that the vaccination is NOT mandatory and that no one is under political, social or other pressure to be vaccinated if they do not wish to do so' and 'to ensure that no one is discriminated against for not having been vaccinated, due to possible health risks or not wanting to be vaccinated'.

Finally, all abovementioned subtle and not so subtle coercion and incentivisation of the covid injection is in violation of the Constitution of the Republic of Finland. In addition, Finland has its own national Act on Medical Research, which provides the same principles for medical research in Finland. Offenses against life and health are regulated in Finland by the Finnish Criminal Code.

* When the injection is administered, the child is exposed to utmostly unknown risks. These are not conventional classical vaccines that contain an antigen, an attenuated pathogen, or a protein that triggers the production of antibodies in the body. Classical vaccines do not increase their concentration after injection. In opposite, they are quickly cleared by immune system along with development of immune memory. COVID-19 jabs are preparations containing either mRNA or DNA coding optimized sequence of one viral protein covered in lipid-nanoparticles, which are protected by patents. After entering human cells mRNA is translated into viral protein and there is a period of constant increase in concentration of pathogenic protein in injected cells. Manufacturer is claiming that produced viral protein is exposed on cellular surface and represented to the immune system, triggering production of antibodies. However, nobody knows what is the distribution of injected mRNA containing particles in the body, how expression of viral protein effect physiology and metabolism of different cell types and what is the fate of adjuvant in the body. Is it safe, biodegradable or does it accumulate in tissues? The long-term effects of these injections are unknown. Noteworthy, viral spike protein

In summary, these experimental injections are gene therapy delivering viral gene coded in mRNA into human body. They are in the testing phase and have been introduced with exemptions. They are misleadingly referred to as 'vaccinations', as the mechanism is not of a traditional vaccine effect. The development of technology is in progress, and the manufacturers' development projects end only in years 2023 and 2024.

can be cleaved from the cell surface and enter circulation. Being a receptor it can bind to cells and trigger metabolic

changes. This possibility is not ruled out by research.

It should be noted, that everyone who participates in the commission of such an act is personally liable, from which, for example, official status and reliance on related obligations do not release from a personal responsibility. It is these responsibilities that are highlighted in international agreements.

We also point out that discrimination on medical grounds is contrary to the Finnish Equality Act.

Violation of this written prohibition at hand, requires the prior written consent of both parents, even if the parents have divorced, and in case the custody of our child has been assigned to only one of us. This ban applies even if only one of the parents has signed it.
